Houston A+ Challenge's mission is to be a catalyst for change and a model for innovation in education in the Houston area and beyond, to ensure that every student is prepared for post-secondary success.

Challenge Network - The Challenge Network continued in 2013-2014 with 18 middle school campuses in 7 districts in the Houston region. An A+ literacy coach and a numeracy coach worked weekly with teachers and curriculum specialists to improve practice and capacity through hands-on coaching, while an executive coach worked with principals and their leadership teams to develop instructional leadership and campus culture. A primary goal of the Challenge Network is to help schools significantly increase the number of students who are not just "proficient", but who are on track to be truly ready for post-secondary success.

4b (Code:) (Expenses \$ 684,837. including grants of \$) (Revenue \$ 7,399.)

A+ Unlimited Potential - A select team of educators created a unique alternative to traditional school models. Teachers became Learning Coaches, designing technology-rich curricula to fit each student's needs. Classes held on-site in Houston's museums and other community resource sites allow in-depth, hands-on learning projects. The school opened in the Fall 2013 with its initial class of 6th graders.

Partnerships and Innovations:

College Access - In Partnership with the University of Texas and The Institute for Evidence-Based Change, A+ worked with 8 community colleges and 11 school districts to transform policies and practices so that more students graduate prepared for success in college, career and civic life.

Technology - In partnership with the Annenberg School Fund, A+ worked with elementary schools in Houston to identify requirements for technology based learning and implement projects when funding secured.
