Leadership Development - Provided individualized leadership coaching and network support for 90 seated principals and assistant principals from across the Houston region. Recruited, trained and supported 19 aspiring principals (selected from nearly 250 applicants) through an intensive six-week summer program and yearlong internship at secondary schools in five partner districts. Convened networks for local superintendents, district executives and higher education leaders to share ideas and best practices from across the region.

4b (Code:) (Expenses \$ 1,469,338. including grants of \$ 565,686.) (Revenue \$)

Partnerships & Innovations - Provided training, network support and funding for mathematics teachers at 25 local campuses (4 through math coaching program, 21 through Reasoning Mind computer-based math program). Students at these schools showed significant gains in mastery-level math achievement. Supported pilot projects in five local districts aimed at transforming policies and practices so that more students graduate prepared for success in college, career and civic life. Helped more than 200 teachers develop workforce-relevant lesson plans, based on their experiences in weeklong summer externships in 68 local businesses. Managed direct grants to schools to promote innovative and promising practices in math, literacy and fine arts integration.

Communications - Published monthly newsletters with resources, news and research for teachers, school leaders and the wider Houston education community. Published an annual report to funders and partners, detailing Houston A+ Challenge's accomplishments. Developed and launched a new interactive website to facilitate communication with educators in A+ networks. Hosted meetings between national education experts and local policymakers.

FACTS & CIRCUMSTANCES TEST

Houston A+ Challenge ("HA+C") submits that throughout its existence to date and in the future, it qualifies as a public charity under Internal Revenue Code §509(a)(1) by satisfying the requirements of Treasury Regulations §1.170A-9(e)(3) as follows:

(i). Ten Percent Test: HA+C has historically, and normally can be expected to in the future, received over 10% of its total support from the general public; the ratio for the past five years was approximately 28%.

(ii). Attraction of Public Support: HA+C participated in the Annenberg Challenge to the Nation to Reform Public Schools, receiving \$40 million from the Annenberg Foundation over 10 years through 2008. As the Annenberg funding ended, new commitments from local foundations and corporations were received in 2008. HA+C has a proven track record of enhancing the public schools in the greater Houston area and the number of benefitted schools continues to grow. As HA+C demonstrates the need and the ability to use the funds effectively, the public support is expected to grow.

(iii). Percentage of Financial Support: HA+C received approximately 28% of its total support from public sources during the past five years and can reasonably expect that ratio to be sustained in the future.

(iv). Sources of Support: HA+C receives its support from a representative number of foundations and individuals, rather than the members of a single family or small group of individuals. HA+C has to date received gifts from over 200 contributors. During the current fiscal year, several new pledges of support have been received.

(v) Representative Governing Body: HA+C's governing body is composed of 17 civic and business leaders. Two members serve on the boards of funding organizations: Maconda Brown O'Connor is on the board of the Brown Foundation and Rosie Zamora is on the board of the Houston Endowment.

(vi). Availability of Facilities or Services and Public Participation: HA+C's programs have expanded to seven Houston metro school districts with total enrollment of over 480,000 children. In addition to working with the teachers and administrators in these districts, getting the community involved in public education is an important part of HA+C's program.

CONCLUSION: HA+C believes it qualifies as a publicly supported charity described in IRC §509(a) (1) pursuant to the facts and circumstances test found in Treasury Regulation §1.170A-9(e) (3). HA+C has and will receive well in excess of ten percent (10%) of its total support from qualifying public sources. It directly and indirectly serves all of the school children attending public schools in the Greater Houston area. HA+C is governed by a public board and possesses all the characteristics that describe organizations that meet this test. Most significantly, HA+C is organized and operates to pursue uniquely public purposes, the betterment of public schools. As a result, HA+C actively seeks public input and support and responds solely to public needs.
